



## **WIN A \$10,000.00 WAYFAIR.CA GIFT CARD (THE “CONTEST”)**

### **Contest Rules and Regulations**

**\*\*\*NO PURCHASE NECESSARY\*\*\***

#### **GRAND PRIZE**

1. There is ONE (1) \$10,000.00 Wayfair.ca Gift Card (“Grand Prize) available to be won by the entrant whose name is selected by random draw (the “Contest Winner”).
2. Grand Prize must be accepted as awarded and cannot be transferred, assigned, substituted, refunded or redeemed for cash.

#### **ELIGIBILITY (\*\*Limit of one Entry Form per person per showhome visit\*\*)**

3. To be eligible for the Grand Prize, the entrant must complete the appropriate Entry Form before 5:00 p.m. (Mountain Standard Time) on Sunday, April 14<sup>th</sup>, 2019 at any of the showhome locations developed by MLC Group Inc. (“MLC”) or its affiliates listed on the Entry Form. The entrant must correctly answer the mathematical skill-testing question on the Entry Form in order to be eligible for the Grand Prize. Entries will be declared invalid if they are late, illegible, damaged, forged, plagiarized, garbled or reproduced improperly.

#### **CONTEST PERIOD AND WINNER SELECTION**

If the selected entrant cannot be contacted within three (3) attempts or three (3) business days of the Contest Winner being selected during the Draw Week (whichever occurs first), or there is a return of any notification as undeliverable, then that selected entrant will be disqualified and MLC reserves the right, in its sole discretion and subject to time constraints, to randomly select an alternate eligible entrant from among the remaining eligible Entry Forms.
